All individuals at 406 are expected to adhere to the rules. Failure to do so will result in fines, and/or ejection from 406 Arena. We support and help in maintaining a clean, safe and community friendly environment for all to enjoy.

Arena, L.L.C. are committed to the following rules. Failure to do so will result in warnings, discontinued use of the facility. We appreciate your cooperation in making 406 Arena a friendly facility for our community. By signing this document, you are agreeing to such.

CODE OF CONDUCT

1. The Open Riding schedule is posted online www.406Arena.com. The arena may not be accessed or used outside of these hours without management permission.
2. Upon arrival at facility and BEFORE use
 - a. Text to check in. INCLUDE: Name, Number of horses, Number in party, where planning to ride, & how paid.
 - b. Pay for facility use: Venmo, Paypal, cash, or check in Dropbox (follow directions on how to leave payment in dropbox)
 - c. Be sure that all in party have read and signed a waiver form. Forms can be left in dropbox. Waivers only needed for first visit.
 - d. All horses must enter the barn through the overhead garage doors, not man doors.
- e. **PLEASE INITIAL THAT YOU HAVE READ & UNDERSTAND a-d** _____
3. Always clean up after yourself and your horse both inside the barn and outside in the parking lot and area surrounding the barn. This includes the cleaning and proper disposal of manure in designated outside area. When finished cleaning please **dump** cart (even if it is not full) and leave empty cart and fork back in designated area.
4. It is required you wear proper riding footwear and appropriate protective gear while riding. Safety vests are encouraged for trail riding. Helmets are recommended for all ages but required for children under the age of 6. Riders under the age of 18 years may not ride without supervision and knowledge/approval of parent/legal guardian.
5. Riders must properly store their equipment in a safe place before and after they ride, ensuring aisles and paths are kept clear and safe. Riders are responsible for securing their equipment, and 406 Arena, L.L.C. will not be liable for any loss or harm caused to others.
6. During open riding times riders cannot monopolize the arena or knowingly cause unsafe conditions. **If your use is limiting other riders, it is not appropriate for open riding**

times. Space must be shared with others in attendance. If using props (barrels, jumps, poles, cones, etc.)

- a. Props must be set up and torn down immediately before and after use. Do not set up until ready to use and take down as soon as finished.
- b. Props must be stored away properly when finished using.
- c. If there are other riders present, gain verbal permission before setting up
- d. Do not force other riders to another area because of your arena use
- e. If new riders arrive while props are in use, stop and gain approval to keep using.
- f. High speeds can be dangerous, especially if multiple riders are present in arena. Gain verbal permission and limit time at increased speeds. Arenas can be rented for private use and also practices can be scheduled to accommodate such needs.
- g. **PLEASE INTIAL THAT YOU READ a-f**

7. Loose horses are only allowed in the round corral and only under supervision. Do not use the round corral as turn out and be respectful of others waiting for use and take turns.
8. Do not tie horses inside ANY arena. Horses should be tied on tie racks whenever possible. If you must tie on the outside of the arenas your horse can not cause problems with those riding in the arena or walking down the alleys. If using a hay net you must clean up after.
9. When on the property please keep safety upmost in mind. Gates and doors to riding areas must be closed when they are in use. Be sure to act appropriately when sharing arena space with others. Pay special attention to young or inexperienced riders and horses.
10. **Dogs are always required to be on a leash.** You must pick and dispose of dog poop. Loose dogs are \$300 fine; second offense animal control will be notified.
11. Any use of stalls, pens, or RV hook ups must be approved by 406 Arena. Additional charges apply for use. Individuals are not allowed in stalls or pens of animals they do not own. Please be respectful, and do not insert yourself or interfere with other horses and riders.
12. Smoking is prohibited in the barn and in boarding areas or anywhere hay or shavings are present. If alcohol is on premise, distribution and consumption must be in accordance with Montana State Laws. Illegal drugs are prohibited anywhere on the property. Please remember that this is a family friendly venue and act accordingly.
13. When riding outside, keep to designated trails or approved areas and only ride during daylight hours. Closed gates mean no access. South of dike is closed Sept-Dec
